Jenn Jacobsen	Academics	Will the learning plan documents be available prior to making a commitment?	Yes, the learning plans for each option, inlcuding level-based schedules will be available as soon as possible.
Jenn Jacobsen	Academics	REMOTE LEARNING PROGRAMS FOR THOSE OPTING NOT TO RETURN: Synchronous learning: Can you shed some light on "one synchronous learning opportunity per week?" Is that per learning area (Math, Science, English, etc) or in total? I think this needs to be broken out by level: elem, mid, high, so all are clear on synchronous learning time expectations within the daily schedule. Part of the issue in the Spring was discrepancy in this area. How does CO plan to close the synchronous variance between schools and within schools?	
Jenn Jacobsen	Academics	NOTIFICATION TO FAIRFIELD PUBLIC SCHOOLS TO OPT BACK INTO IN-PERSON LEARNING: How did you decide on 10 days notification? Starting with day 10 of the school year, every day is a day 10, so teachers can expect to possibly receive a new student each day starting with day 10? Did the reopening committee consider at the marking period or semester, as that seems to be the way most are going?	We believe that by waiting until the end of a marking period or semester we would be ignoring the family or personal circumstance changes that may have prompted a request to switch models. We selected 10 days because that seemed like a reasonable amount of time for students to complete the expected work in the model they were in and allow staff to make the necessary class placement transitions.
Jenn Jacobsen	Academics	Can those who choose in person, opt into voluntary remote? This is not a provision in the state plan. Clarifying if that is an option and, if yes, is there the same 10 day notice?	The state does allow parents to move between the two options. They do not provide a time frame for the transition and leave it to each district to decide.
Jenn Jacobsen	Academics/Communi cation	How will grades transfer between teachers in IC? Will the grades from teacher 1 be included in cumulative grading with teacher 2, 3, etc. if students are assigned different teachers throughout the year?	We would follow existing practices for student transfers. Teachers usually speak together to determine the best way to measure student growth and performance.

Jenn Jacobsen	Academics	I am clear on why students will need to change teachers if they choose voluntary remote and then opt back in to in person. Can you help me understand why students who become ill or have to quarantine as a class would need to change teachers? This seems very disruptive to the continuance of learning, unless all teachers will be on the same page, unit, lesson, book choice, assessment etc. each day. Is there an implementation plan breakout available for this provision of the FPS plan and did the reopening committee utilize technical assistance from CSDE on this? How does this provision of the plan support the focus on SEL stated in the plan?	
Jenn Jacobsen	Academics: Assignment and Course Expectations	The Homework Policy posting timeframes will remain? The grade input timeframe will remain?	Yes, those policies remain in effect.
Jenn Jacobsen	Schedules	For in-person learning, "building schedules will be delivered as determined by the building principals". Could you shed some more color on what is meant by that?	Although the hours of operation are the same by level (elementary, middle, and high), the daily schedules vary from building to building, thus each building principal is prepared to provide a schedule for in-person learning.
Jenn Jacobsen	Schedules	Right now our plan calls for 2 days a week in person in the hybrid model. That is 40% of time. Can you share how the committee determined that number versus using 5 days in a two week block, giving students 50% time in each mode? that 1 day difference is over 100 less hours in person over the year and 100 more hours of families covering that time.	This allows for us to rotate two groups of students (i.e. cohorts) for in-person learning in a hybrid model. The two groups would be in-person for two days and working independently, remotely two days. The fifth day would be used to provide synchronous support to the whole class of students. This reduces the amount of potential exposure given the reduced number of students in the building at any point in time (50% of capacity).

Jenn Jacobsen	Magnet Programs	For those choosing voluntary remote, this means they cannot participate in magnet programming? For in person, will magnet run as long as the magnet school is open? I know we were awaiting some guidance around interdistrict transportation. Did that come in?	We have not yet received information on magnet school programs or transportation.
Jenn Jacobsen	Preschool	The State plan addendum for preschool does not require pre-k students to wear masks. Is FPS requiring preschool students to wear masks, except for those who are unable to?	No. The FPS Special Education and Related Services Reopening Plan is being revised based on the updated guidance from CSDE regarding preschool students no longer being required to wear face masks.
Jenn Jacobsen	Special Education	The plan calls for services such as PT/OT and speech to possibly occur in the general education setting. Will that be happening while another teacher is simultaneously teaching the rest of the class?	In an effort to minimize student movement throughout a school, when feasible, related services should be delivered within the student's general education setting, special education setting, or remote learning setting as deemed appropriate based on individual student's needs. This determination should be made by those with the greatest knowledge of the student and may differ based on the age of the student, severity of disability as well as the related service being provided.
Jenn Jacobsen		Are there any courses that you have identified that will not run? Can some of these areas, where possible, be held outdoors? Can "assemblies", concerts, etc. and the like be held virtually instead? Can you share how the committee decided to not use recess as one of the mask breaks?	We have not identified any courses yet that will not run. We are encouraging the use of outdoor classes. We will work with staff to make virtual assemblies and concerts possible. We are aware that some parents want their students to have masks on for recess and for PE. We also believe that recess may serve as a needed third mask break for elementary students.
Jenn Jacobsen	ELL	Bilingual education will continue to be offered in all modes?	Yes.
Jenn Jacobsen	extra-curricular	Do we have a list available of what clubs/activities will be available virtually?	We do not have that list yet.
Jenn Jacobsen	extra-curricular	I know the state allowed districts the option to not allow those who voluntarily opt out of in-person to participate in extracurricular activities, but it was not a requirement. How did FPS decide to exercise this option? Does this possibly pose a risk of loss of said activity for those who are in person, due to small number?	We are not allowing this option in order to reduce the number of cohorts whenever possible. We are concerned with allowing students who have opted for remote learning to join with students that are monitored during instructional days.

Jenn Jacobsen	Academics	What is the maximum number of teachers high school students could have in the year under the plan when accounting for a 14 day quarantine process and taking 8 classes? Same for middle school and elem. using their course/class load?	If each course is a semester, the maximum number of teachers for high school students would be 16, assuming a full schedule. For middle school students, it would be 7 teachers and for elementary students it would be up to seven teachers over a six day cycle.

		"Face covering is a cloth covering that completely covers the nose and mouth." Would the cloth mask shown above be acceptable?	I have ordered some of the masks described and would like to inspect the seal between the cloth and the plastic shield before commenting on its acceptability. Aside from covering the nose and mouth, the covering should provide a good seal. If the seal is tight, I see no problem with its use and think it would very helpful in certain classroom settings.
Jenn Jacobsen	Parent Expectations	What is the definition of "presumed" Covid Case in this instance to go into quarantine?	Presumed case is one in which the individual exhibits COVID symptoms but test results have not yet been received. Presumed cases should be advised to isolate until test results are received or until they meet CDC criteria to end isolation.
Jenn Jacobsen	Parent expectations	Clarifying: if you have had close contact with a confirmed or presumed covid case it is 14 days quarantine but if you actually have covid or symptoms of covid it is 10 days to return to school?	Yes, the quarantine period during which the disease may develop after exposure is 14 days. Available data indicate that persons with mild to moderate COVID-19 remain infectious no longer than 10 days after symptom onset. In addition to the 10 days after onset, the individual with CoVID must be fever free for 24 hours and have an improvement in symptoms.
Jenn Jacobsen	Bathroom Protocols	Clarifying: If a building decides to use the bathroom shift model, students can still use the restroom if needed, outside the shift correct?	Yes.
Jenn Jacobsen	Playgrounds	Playgrounds can be used but only with social distancing and a mask? Will playgrounds be open before school bell and after dismissal? Will on-site after school programs be able to use the playgrounds?	The town has opened all playgrounds. After school hours, the playgrounds are restricted to the after school programs
Jenn Jacobsen	Ventilation	Can you address the concept that COVID can spread through AC? During the parent webinar it was mentioned that if it was too hot in school, there would be early dismissal. Do we have a set point at which that would occur? And is that building specific or whole district/whole level?	We are working with the health department to establish that standard. It would apply to all schools in the district. Even schools with AC will be sending home students on buses that lack AC. New filters being used in the schools should reduce the ability for COVID spread through AC system in addition, effective mask use should reduce airborne respiratory droplets.

If extra runs are required, do we have an idea of how late, late would be?	We won't know until the number of students returning, and requesting transportation is known.
Jenn Jacobsen	Health Protocol	How are we on having sufficient supplies for cleaning, sanitizing, and PPE?	We have sufficient supplies on hand and distributors lined up to help with restocking as needed. Once we have a better understanding of our burn rates, we will be able to place orders more quickly – as needed.
Jenn Jacobsen	Health Protocol	What will be the decision making metrics for closing a class, a school, the district as a whole? If closing a school, would this be done at the early dismissal time if possible? If needed earlier than the standard early dismissal time, would this possibly lend itself to having different end of school dates for each building?	
Jenn Jacobsen	Health Protocol	If a school is closed, does this mean that the limited outside organization use of the grounds would also be closed?	We believe that outside organization use is already restricted and will likely continue to be so.

Jenn Jacobsen	Immunizations and Health Records	Do you think we should clarify in the plan that the immunization schedule remains and health records are good for 15 months (not the customary 13) in the plan?	I don't think this is necessary but if you feel a sentence or two would reassure parents, that would be reasonable.
Jenn Jacobsen	Face Masks and other Personal Protective Equipment	#6 sentence is incomplete. What should that read as?	Principals will establish "Mask Break" times in the schedule that will occur throughout the day. Teachers will be given autonomy to provide breaks as necessary and appropriate.

Those are likely to be 2 different numbers.	This means 50% of the in-person student capacity. We expect adults to maintain 6 foot distancing from all other staff and from students.

Jennifer Jacobsen		With the calendar proposed on the August 4th agenda, how many days of in person classes does this afford a high school student for the 2020-2021 school year?	There are 179 school days and based on the AB/AB hybrid model selected, students meet with their teachers for 106 out of the 179 days.
Trisha Pytko		I read that visitors will not be allowed to enter FPS schools, but are student teachers, interns, and college students completing "required hours" going to be considered to enter the schools?	We are hiring interns and building substitutes but do not consider them visitors.
TRisha Pytko		Are classes like art and science going to use disposable equipment, student-assigned equipment, and/or cleaning after each class?	Art classes will have personal supplies assigned to each student. As for Science, I am not sure yet as to how this will look. We will need to get more input from the science coordinator before any decisions are made.
Trisha Pytko		PTAs generally run parent events on the first day of school, inside and outside of the building. Are parents not going to be allowed to go to their child's school except for emergencies?	That is correct, we are not allowing outside activities at this time.
Trisha Pytko		provided to the magnet schools, for	Our in-district transportation needs are yet to be determined. Once they are known, and we know the schedule for magnet school, we will do our best to provide transportation to all eligible students that request transportation.
Trisha Pytko		Has any thought been given to different efforts for hiring subs and training them on safety measures?	Yes, we have started to look at this.
Trisha Pytko		Has there been a need to hire more custodians for the upcoming school year?	We are still working on a plan for full coverage for the upcoming school year.
Trisha Pytko		Do we need to hire more PT,OT, CCSN staff, SLPS in order to meet the identified IEP service hours need in the classroom?	We are still in the process of determining these needs.

In an effort to minimize student movement throughout a school, when feasible, special education and related services should be delivered within the student's general education setting, special education setting, or remote learning setting as deemed appropriate based on individual student's needs. This determination should be made by those with the greatest knowledge of the student and may differ based on the age of the student, severity of disability as well as the services being provided. Site of service delivery may differ based on specific requirements of student IEPs. For example, students with disabilities placed in CLC classrooms who also participate in general education classes may attend the general education class live or remotely, based on the determination of those with the greatest knowledge of the student's needs.
Trisha Pytko		Will teachers be allowed to stream live during instruction from their classrooms?	At this time we are not allowing this practice.
Trisha Pytko	Page 21-Health	Will students be allowed to wear a mask and a face shield if they chose to?	Yes, any additional barriers will aid in the mitigation but will not be required or provided.
Trisha Pytko	PAge 21-Health	For appropriate PPE, will students and staff be allowed to bring in and wear a neck scarf in place of a mask? (They are selling these where they can pull it up over their nose, but it goes around their neck)	We will work with the Executive Director of Special Education to determine who will be most suitable for this role.
Trisha Pytko	Page 40-assistive technology	Who will be responsible to cleaning and/or wiping student assistive technology throughout the day?	Yes. Information will be provided to parents prior to the start of school on supporting the social-emotional learning of students through the CASEL framework (Collaborative for Academic, Social, and Emotional Learning). Supporting the social-emotional learning of students, parents and staff will be a district priority throughout the 2020-2021 school year.

Trisha Pytko	Page 52- lunch	Is there a safe way for students to have lunch in the lunchroom rather than the classrooms in elementary? Will students be told not to bring any food into the classroom (at any time of the day) that a student may be allergic to?

We are asking that staff do not bring in their own supplies (due to many product differences and unknown recalls). We would not be able to trace anything back to the product in case someone was to have a reaction.

Trisha Pytko		In elementary school, parent volunteer to supplement the science curriculum with a program called CANE. Will this still happen? will the teachers use this curriculum instead?	We are not allowing volunteer programs at this time. Mr. Wakeman will need to address the use of the CANE curriculum when he returns from vacation.
Jeff Peterson	Facilities & Operations	Will students be allowed to check books/materials out of the library? Will they be able to use them while in the library?	The Library Media Specialists (LMS) have a plan for book selection. This includes digital browsing that the LMS can then check out and deliver to the student. Once returned, the book will sit for 72 hours before being put back in circulation. Those books being used during class will be out of circulation for 3 days.
Jeff Peterson	F&O, p13	Can you give an example of a door that should be propped open but does not create a safety concern?	No door will be propped open without a staff member assigned to it. We are referring to interior doors, such as bathrooms.
Jeff Peterson	F&O, p14	Will the "protocol practice day" be mandatory for all students?	It is not a school day so we cannot make it mandatory. We expect it to be of high interest and will publicize repeatedly.
Jeff Peterson	Transportation, p19	Will parents waiting with children at bus stops be required to wear masks? (And will parents dropping kids at school be required to wear masks while doing so?)	
Jeff Peterson	Health Practices, p23	Is there a reason we are defaulting to a 100.0F temperature rather than the CDC threshold of 100.4?	The 100.0 parameter was established in the State's rules for summer school. The CDC guidelines came out the day before the State plan was due and those guidelines were not incorporated into the submitted plan. I understand the state DPH will be releasing a comprehensive document this week detailing Health Office management that addresses those scenarios.

Jeff Peterson	Health Practices, p23	Self Screening #2 says students will be allowed to return to school 24 hours after a fever has broken with a note from their healthcare provider or a documented negative CV test. This seems MUCH more restrictive than the CDC's return-to-school recommendations, which say students with one or more of the constellation of symptoms manifested in Covid should be evaluated in the context of the "existing school illness management policy." Please clarify: are we going to start requiring a doctor's note for ALL illness-related absences? If this is the case, we will need to look at Policy 5113. Note that on p24 we say the School Nurse will advise parents of symptomatic students that students are not to return until they have met CDC criteria to discontinue home isolation. Is this for students that have displayed one or more symptoms but have not had a test? Again, the CDC says "Schools should not require testing results as a part of return to school policies."	Again, these plans were developed prior to the release of the CDC guidelines and were based on the current state rules for the summer program. I anticipate much more guidance from the state later this week that I presume will incorporate the recent CDC guidance in their recommendations.
Jeff Peterson	Health Practices, p27	Will all schools have designated outdoor instructional spaces and/or tents? Will these be allocated on an ad-hoc basis or will some programs meet there regularly? What will happen in inclement weather? Are there safety concerns with outdoor classes in spaces that are not otherwise surrounded by the building?	Tents will be provided and staff will be encouraged to use outdoor spaces as much as possible. These tents will also support the social distancing needed during lunch.

Jeff Peterson	SEL, p46	I think the public would benefit from a description of "Restorative Practices," which was not obvious to me.	Restorative practices are a means of addressing student misbehavior that puts greater emphasis on learning from past mistakes and "making it right" with the affected other party. Restorative practices draw their strength in their ability to empower students to learn from unacceptable choices, to understand their impact, and to grow personally in their ability to make more sound decisions and resolve problems. Restorative practices represent a positive step forward in helping all students learn to resolve disagreements, take ownership of their behavior, and engage in acts of empathy and forgiveness.
Jeff Peterson	Electives, p49	I have many questions about music. #6 here says concerts will be limited. My understanding is that concerts form a key component of the music curriculum. How will this gap be filled?	We will need to develop alternative approaches to concerts as students will not be able to separate twelve feet on stage to perform. Moreover, visitors and viewing would not be allowed.
	12 feet???	Beyond this document, the webinar said vocal students would be required to practice social distancing of 12', presumably while singing. I cannot see how this will work. My son is a member of the FWHS Chamber Singers, probably one of the smaller choral groups, and it's still 20-25 kids. The geometry of running this class with kids spaced at 12' radii represents a huge space that will far outflow the Warde choral room. Will these classes perhaps be held instead in the auditorium, or even the gyms (though these are going to be half-filled with disused furniture)? Indeed, chorus is one of my great questions overall, because we saw at the beginning of the pandemic how singing in close quarters puts performers at very high risk. Are masks satisfactory to moderate this risk, and if so why the 12'? Or will we allow them to perform without masks, but spaced? And this doesn't even begin to touch on the similar challenges facing wind instruments (and we have such great Wind Ensemble programs).	large spaces. Yes, there will not be any structural work done in the bathrooms. We will be taping off/ turning the water off on specific sinks, stalls, and urinals.

We cannot require parents to buy any necessary instructional materials. We will provide students with any resource needed to implement the curriculum.
Jennifer Maxon Kennelly	Classroom Cleaning Protocol	How many bottle filling stations do each of our schools have? And if PTAs were interested in donating more, is that possible? Whom would they contact if yes?	With the exception of Burr and McKinley, all schools have at least one bottle filling station. We have ordered filling stations for the two schools mentioned. We have always allowed the PTA to donate bottle filling water however, the order time as of now is sometime late October
Jennifer Maxon Kennelly	Food Services	Will we still be able to provide lunch for students who select full time remote, at least if they are identified as F/R lunch?	Yes, we are required to provide meals to F/R students even if they are remote students.
Jennifer Maxon Kennelly	Transportation, etc.	What will be the procedure for deliberate noncompliance with mask-wearing and other necessary safety measures? And I would earnestly hope that we would have our own internal measure for teachers to electronically submit discipline referrals for noncompliance including others present at the time, as a potential means for our own internal contact tracing.	The consequences for not wearing masks will be based on developmental appropriateness. For students with a behavior plan, staff will follow the steps in their plan. For students without a behavior plan staff will follow the traditional disciplinary procedures, including notification of the child's parent and members of the administrative team at the school.

Jennifer Maxon Kennelly	School Access	Parental/Guardian noncompliance?	At this time, we are restricting access to the schools to everyone in order to keep our staff and students safe. Parents who need to come to the school will only be allowed to do so with a scheduled appointment and will be required to wear a facial covering and complete a COVID self-assessment upon arrival. Principals will notify a member of the Executive Directors team for support when they have a parent who repeatedly defies these expectations, which are in place for everyone's health and safety. If necessary, we will involve FPD.
Jennifer Maxon Kennelly	Academics	I do not see how parents can be expected to make an informed decision (remote vs. hybrid/full) without ANY specific plan being published regarding the daily schedule, especially the daily schedule for remote	This is a concern at each level. The typical in-person master schedule cannot be translated to a remote schedule. The district leadership team is working on a standard remote learning schedule that will take into consideration the amount of time for "live" video instruction and asynchronous tasks in each subject area.
Jennifer Maxon Kennelly	PD	Will principals be conducting any remote meetings in next three meetings to address the concerns of staff in their specific buildings?	There is new information daily. We will look to hold meetings as we get closer to the start of school.
Jennifer Maxon Kennelly	Tech.	Reason for why grades 3-5 won't receive chromebooks until mid-late September?	The Chromebooks have been ordered; however, we are one of a number of districts across the country who have submitted orders for them. Jennifer Maxon Kennelly	Academics	Do we have any state guidance yet on the teacher eval. process? Regardless of state "relaxing," do we have any plans of our own in this regard?	There are not plans on this yet. I will be learning more about how the state plans to approach this in the coming weeks.
Jennifer Maxon Kennelly	Academics	Can we stipulate explicitly at the start of the year that HS students should plan on there being no pass/fail option?	We would not say that now. We do not know how this year will unfold.

Students will be assigned a lunch wave based on their grade level and/or class that they are in during the lunch period. Under the hybrid model 50% of the students would be in the building on any given day, reducing the number of students in the cafeteria. The number and location of lunch waves will need to be increased if the 100% in-person learning model is implemented. The additional locations would include, but not be limited to tents adjacent to the cafeteria.

Could you please explain why you believe this is not a viable option? If we do a hybrid plan, would you reconsider?	When considering the option we weighed the benefits of the model. Having children live stream into a class opens the class up to a number of circumstances that the teacher cannot control. Beyond this, we have to consider which option is best for learning - having a child watch a lesson with little interaction or working on content and skills independently or in a small group where feedback is later received. We know that there is no real replacement for a consistent teacher in a classroom with students. There are concerns about the impact of students viewing classes on screens for 6+ hours every day. Additionally, there are privacy concerns which would need to be addressed in addition to the cost associated with equipping classrooms to support live streaming. We have around 984 classrooms, or 647 full size classrooms, so outfitting only the full size rooms will range from \$776,400 to \$2 million.
