Re: Kindergarten Entrance Inventory Results 2023

Each fall, the Connecticut State Department of Education requires kindergarten teachers to submit data on each child's preparedness for kindergarten. These data are collected annually since 2007 as a result of Public Act 05-245. The assessment tool is named *The Kindergarten Entrance Inventory* (KEI).

These data are now posted on <u>EdSight</u>. For more information on the KEI, the teacher handbook is located <u>here</u>. The *Kindergarten Entrance Inventory* is located <u>here</u>.

Briefly, the KEI measures each student on six domains developed from curriculum frameworks in language arts, math, and preschool, including: (a) language skills, (b) numeracy skills, (c) physical/motor skills, (d) creative skills, and (e) personal/social skills. KEI results are reported in three performance groups by domain:

- Performance Level 1 emerging skills; substantial instructional support required.
- Performance Level 2 inconsistent demonstration of skill; some instructional support required.
- Performance Level 3 consistent demonstration of skill; minimal instructional support required.
