# Year Enrollment Projection Update For 2025-26

October 7, 2024

## Assumptions for 2025-26

- New Kindergarten entry date became effective for 2024-25 school year per state law.
  - Cutoff date shifted from January 1<sup>st</sup> to September 1<sup>st</sup>.
  - Parents of students who turn five years old after September 1<sup>st</sup> can apply to enter kindergarten early via a "waiver" process.
- For 2024-25, parents of students who turned five years old could choose to "opt in" to kindergarten this year. 72 students, or 11.7% of this year's kindergarten class, turned five years old after September 1<sup>st</sup>. This is a lower number than in prior years before the new entry date went into effect.
  - This aligns well with prior projections, with this year's kindergarten enrollment within 2 students of the projections.
- For 2025-26 and beyond, FPS plans to implement an assessment process for students requesting a waiver. This is anticipated to result in a slightly lower share of 4 years olds enrolling in kindergarten compared to 2024-25.
- The kindergarten projection was revised downward slightly for 2025-26 to account for this change in policy.
- Pre-K enrollment was held constant from 2024-25 levels at 211 students.
- Enrollment at Walter Fitzgerald Campus was held constant at 73 students. Note that this includes 30 students in the CPP program (ages 18+) which are classified as 12<sup>th</sup> graders.

#### Special Policy Committee Meeting Minutes Monday, September 30, 2024 5:00 PM

Call to Order: Ms. Maxon Kennelly called the meeting to order at 5:00pm.

Approval of September 16, 2024 Policy Committee meeting minutes: Approved by a 3-0 vote.

#### Policy:

#### 3515 - Community Use of School Facilities

Ms. Guernsey thanked the committee for allowing this policy to be reviewed. Ms. Guernsey stated this policy is a duplicate of policy 1330 which is slated for deletion. Ms. Guernsey stated she believes the regulations to this policy have been updated, therefore, she would like the policy to be reviewed to ensure it aligns with the updated regulations. Ms. Guernsey stated she finds the regulations very confusing. Ms. Guernsey stated she has received feedback from the community who feel the same way.

Ms. Guernsey explained she added language to this policy for the committee to review and provide feedback. Ms. Guernsey added language about the annual report and revenue as well as rental rate changes. Ms. Maxon Kennelly asked Ms. Guernsey why some language was in blue. Ms. Guernsey explained she cut and pasted language from other districts so the committee could decide whether or not to add similar language to our policy.

Ms. Jacobsen stated she does not have any questions right now about this policy. Ms. Jacobsen agreed with Ms. Guernsey that the policy needs to be reviewed. Ms. Jacobsen and Superintendent Testani both agreed the definitions should be added to the policy.

Ms. Maxon Kennelly asked Mr. Papageorge to update the regulations first so the committee can work on updating the policy.

The policy and regulations will be reviewed and discussed at the next Policy committee meeting on October 14<sup>th</sup>.

#### 5114 - Suspension & Expulsion/Due Process

Dr. Zavodjancik stated he does not have any new information to provide to the committee on this policy. Dr. Zavodjancik stated he did make formatting and grammatical edits the committee recommended from last meeting.

This policy was approved by a 3 -0 vote. The policy will be presented to the Board on October 22<sup>nd</sup> for a "first read".

#### <u>4111-4211 – Recruitment & Selection</u>

Ms. Ingram explained she made edits to this policy based on the model policy from CABE. Ms. Maxon Kennelly stated the feedback she has received about this policy is to add language about having a BOE representative on interview committees for Central Office administrator positions.

Ms. Jacobsen stated she does not agree with the last paragraph on Page 31 referencing Title I because she believes that section should be in the Title I policy. Ms. Jacobsen explained parents would not know to look for that language in this policy. Ms. Maxon Kennelly agreed with Ms. Jacobsen.

After further discussion, Ms. Ingram agreed to make further edits to this policy as well as the Title I policy 6172.4 to be reviewed at the next policy committee meeting on October 14<sup>th</sup>.

#### <u>5141.231 – Psychotropic Drug Use</u>

Mr. Mancusi stated this policy has not been updated since 2004. Mr. Mancusi explained the legal references needed to be updated and the definitions were added. The committee requested the legal reference "34 C.F.R. § 300.174" be written out. The committee also requested on Page 37, in the last sentence of the last paragraph changing "(i)" and "(ii)" to "1)" and "2)" so that the format aligns with the rest of the policy.

This policy was approved with changes by a 3-0 vote. The policy will be presented to the Board on October 22<sup>nd</sup> for a "first read".

#### 5118.1 - Homeless Children and Youth

Mr. Mancusi stated this policy was originally slated for deletion; however, he is recommending that we keep this policy and then delete policy 6141.313 instead. Mr. Mancusi explained this policy is current whereas policy 6141.313 is outdated. Dr. Parrish added there are regulations that go with this policy but not with policy 6141.313. Mr. Mancusi stated only the legal references were updated in policy 5118.1.

Ms. Jacobsen made a motion to add policy 0300 Policies for the Fairfield Public Schools to this policy agenda for discussion. Ms. Maxon Kennelly seconded the motion. The motion passed by a 3-0 vote.

Ms. Jacobsen requested that we add the following language to policy 0300 in the last paragraph of the policy: "*Updated legal references will be noted and dated in the policy history notes as legal references updated*". This change to policy 0300 was approved by a 3-0 vote. Policy 0300 will be presented to the Board for an "approval with changes" at the October 22nd meeting.

Since only the legal references were updated on policy 5118.1, the committee agreed to "hold" on this policy until after the October 22<sup>nd</sup> Board meeting so that policy 0300 can be reviewed and approved.

#### 6141.313 - Homeless Students

This policy will be presented to the Board at the October 22nd meeting for "deletion".

#### <u>3516.3 – Accidents</u>

This policy is scheduled to be presented to the Board at the October 22nd meeting. It will be removed from the "one and done" list and be presented for an "approval with changes".

#### 5143.2 - Accidents

This policy is recommended for deletion since it is a duplicate of policy 3516.3. This policy will be presented to the Board at the October  $22^{nd}$  meeting for a "first read for deletion".

#### <u>6151 – Class Size</u>

There was no discussion on this policy. This policy will be on the agenda for the next policy committee meeting scheduled for October 14<sup>th</sup>.

**Open Discussion/Public Comment:** There was no open discussion or public comment.

Adjournment: Ms. Maxon Kennelly adjourned the meeting at 7:12pm.
