January 26, 2016

1. A copy of the contract/agreement with Curriculum Associates related to iReady, including pricing, terms and conditions.

There is no contract. Please see [Attachment 1](#) for the price quote that was used for purchase.

2. A copy of the contract/agreement related to STAR, including pricing, terms and conditions.

Please see [Attachment 2](#). The price is set by the RESC agreement.

3. Sample reports for STAR related to proposed math assessments.

We will customize the parent reports for math, as we are for Reading, and we have not yet done that. We are working on Reading right now.

4. Copies of the "Changes in Staff" reports since May 31, 2015, previously provided to BOE monthly.

The HR office is working on generating a similar report.

5. A copy of the Food Service contract/amendment with Whitson's Food service under which the district is currently operating.

7. "Class size and average sizes and section counts" reports for the high schools, as provided in the last two budget cycles.

The class size report is not easily extracted from a "predefined report" using our student information system. In fact, the only report that we can extract from Infinite Campus is quite confusing and required hours of work on the part of many staff members. Because of state reporting, all students must be linked by their state assigned student ID number to their course by course number and to the teacher by teacher number. This creates quite a problem when attempting to extract a class size report from Infinite Campus. For example, for any combined class, such as Chinese 3 & 4, in which the same teacher is teaching a class of 22 students, the report would show 2 different classes, giving the impression that we are running one class of Chinese 3 with 14 students and one class of Chinese 4 with 8 students, when we actually are running one class with 22 students. We have many classes in both high schools where classes are combined. A similar problem occurs with Learning Center classes or Math workshop classes, where many students are assigned to the same classroom but for different reasons (from different classes for additional support). In those cases, the class size report from Infinite Campus shows multiple, very small different classes, which in fact are all the same class taught by the same teacher. The last time we pulled the report from IC, it was 175 pages and took a minimum of 3 weeks to refine. It also required the work of several data specialists and high school and central office administrators to find the errors, correct them, and then produce the report in a readable format for the Board.

The high school class size chart on page 133 in the budget book gives a good summary of current class sizes for each high school. At the bottom of the chart there are explanations as to why some classes are under 15 and others over 28 are unavoidable. It is important to remember that one of the goals of the new high school schedule is to give every student lunch while opening one more period to provide more opportunities for additional courses. As a result, there are many more student requests for courses which may cause some classes to be larger than they were in the past or it may cause classes to split. When enrollments for a section get too large, splitting the section may result in imbalanced sections due to the schedule, creating a larger enrollment in one section and a smaller enrollment in the other. However, these scenarios are created to provide all students with as many courses as staffing allows.

8. On p. 69-71, virtually every school is estimated to need far more funds for subs that were budgeted, yet all maintain the same budget allocation for 2016-17. Why is that? And from where do they generally get those funds when they run short?

It is impossible to predict actual substitute needs. Funds are recouped from salary accounts from staff who are out on an unpaid leave of absence.

9. On p. 74 133 Staff Replacements...I don't quite see where the 16-17 number comes from, given the information on p. 32 regarding this topic.

Please see the description on page 32, summary object 133.

10. On p. 75, line 52091 what IS "program assessment" that comes with such a cost? Beyond the PSAT funding.....

We moved all of the expenses related to the DIP to this line. The only new expense is PSAT 9.

World Language testing is in this year's budget, same line.

PSAT this year was paid for by the schools, but we are paying for it at district level starting next year.

Post Graduate survey is in this year's budget.

Middle School Tech Assessment is in this year's budget. We are using this to monitor our students' use of technology before they go to high school.

STAR was moved from the Technology budget.

11. On p. 82 54790 what is the painting job(s) that is so high? **Please see Attachment 4.**

12. On p. 87 and p. 150....my one addition to the District Improvement Plan was the "nod" to the tremendous benefit accrued from the strategic hiring of outside "experts" to support PD. It is not apparent from these pages if any is being done for this upcoming budgeted school year, but I wanted to confirm that impression.

We do that as needed, keeping in mind that we have some talented teachers and administrators here who have expertise that we should not ignore.

Special Education brings in experts from the field to address "best practice" standards whenever needed.

13. On p. 133, I was wondering to what degree the new high school schedule has improved or exacerbated the issue of class sizes. Over 28 in a class is bad enough, but even the tremendous number over 24 is disconcerting. (also, could this possibly be mitigated by another review of the science "mini" and the change to PE classes restricted by grade).

There is no connection between the new high school schedule and class size. Class size is determined mainly by enrollment and FTE.

Regardless of the schedule, classes that are scheduled against singletons (such as band) will be impacted by that, which is unavoidable.

Eliminating the science mini would create open periods in a student's schedule, not reduce class size.

I don't think the PE structure would impact class size, although we have not looked at that specifically in terms of class size.

14. In addition, the amount spent on special education reported to the state in the below table is materially different from the amount reported on page 123 of the Superintendent's Proposed Budget (reported line 1200 as \$19M). This number was the subject of much debate at last week's meeting and clarification would be appreciated.

Please refer to question #41 in the Board Member Questions from January 22, 2016 (in the January 22 Friday Packet).

15. As requested Tuesday, please provide data for:

Expenditures for special education, including such expenditures as a percentage of total expenditures, as well as the associated populations for 2009-10 school year up to the proposed 2016-2017* budget. Please complete the following data table which should be consistent with what is reported by the state for the district (based on data the district provides).

Available data was added in red to the table provided (please see [Attachment 5](#)). ELL and Gifted expenditures are not reported to the state as separate programs, therefore, indirect costs are not allocated and there is no true representation of program costs. In addition, since the state does not collect this data there is no comparative analysis.

16. What are the comparable statistics for other large districts in DRG A and B (over 5,000 students), include West Hartford and Greenwich. In other words, please provide the last 5 years of the chart for those 2 districts and others you believe are good comparables. I would imagine much of it would be available in ed001 and state filed stats. Thank you again for the effort.

The data elements are attached for every district in the state including West Hartford and Greenwich. There are a number of large districts (over 5,000 students) and whether or not they are comparable is subjective. Please see [Attachment 6](#).

17. In addition, can you please provide the following for the last 5 years:
- i. achievement data for special education students,
 - ii. rates at which students identified as requiring special education are no longer identified as requiring special education,
 - iii. the availability of supplemental educational services for students lacking basic educational skills,
 - iv. the amount of special education student instructional time with nondisabled peers,
 - v. the number of students placed out-of-district, and
 - vi. the actions taken by the school district to improve special education programs, as indicated by analyses of the local data provided above.

We are not able to provide this information on short notice. Furthermore, this request is essentially a full program review of special education, which is beyond the scope of the current budget deliberations. Ms Leonardi can answer questions about the programs and efforts to improve them at the meeting.
