

Dear Dr. Jones:

On May 3, 2017, the Connecticut State Board of Education ("CSBE") accepted a report concerning the racial imbalance statistics for all schools in the state. This report indicates that McKinley School continues to be racially imbalanced. At the January meeting of the CSBE, the Fairfield Board of Education ("Fairfield Board") made a presentation of its proposed amendment to the plan to address the racial imbalance at the school. The CSBE conditioned its approval of the Fairfield Board's amendment upon Fairfield submitting a revised amendment within 120 days.

The Department of Education has received your amended plan, and we will be in touch soon to discuss the schedule for consideration by the CSBE.
