I. Call To Order

Mr. Donald called the meeting to order at 7:31pm.

II. Pledge of Allegiance

III. Project Update

Mr. Manning reported that the roof contract was issued to Allied Restoration.

Mr. Manning distributed a handout covering the base bid results for the additions (Phase 2), which was reviewed with the Committee; the difference between low bids and low response bids was clarified. The following bid packages need to be re-bid: concrete, general trades, electrical. December 23 is the next date to take bids, and December 24 is the scope review. The second page of the handout covered the VE (value engineering) analysis for Phase 2.

IV. Budget Update

Mr. Dell'Accio distributed a handout which covered the estimate comparison (no Phase 2 numbers included). He also distributed a handout focusing on estimates for Phases 1 and 2 only, which shows the project under budget (without the windows). If the windows portion of the project is to be done, it needs approval from the Town.

Mr. Morabito added that if the decision is delayed regarding the windows, they may not be done until starting 2016-17, and completed 2017-18 (two summer project).

V. Discussion and Approval of Contracts for Phase 2

Motion to approve the following made by Ms. Leopold and seconded by Ms. Ertel:

- ---to award BP-31A Sitework to J. Iapaluccio, Inc. in the amount of \$649,425
- ---for the Town to issue a PO to Yankee Electric for not to exceed \$5,000 to perform enabling

work
